DIVISION UPDATES

Nursing Division:

2014 brought about a massive change in the services provided in the Nursing Division. One of the biggest changes has been with the private purchase vaccine. By purchasing vaccines from the manufacturer and maintaining our ODH supply, we are able to continue to be a resource for our residents. Our staff have also worked tirelessly to implement our Electronic Medical Records (EMR) technology in our Reproductive Health and Wellness clinic. Our staff was trained in July and began using the program in August. This program will increase the efficiency of how we provide services to our clients and will make it possible for us to share records with other healthcare agencies. Finally, our billing staff have improved the way we bill for the services we provide. In addition to increasing the number of insurance companies who we are contracted with to provide services, our staff completes the needed follow-up to assure that we are reimbursed properly.

WIC Program:

In 2014, Allen County WIC tried several new and innovative education methods to promote healthy eating, breastfeeding, safe and healthy child care practices and healthy lifestyle activities for new parents. One new and innovative concept was a prenatal baby shower held for 85 new WIC moms in the county. The educational party was a collaborative effort among WIC, Heartbeat of Lima, CareSource, Help Me Grow, Caring For Two, and the YWCA Resource Center. The goal of this educational function was to improve the health and well-being of our newborns, help families prepare for their new arrival and provide fun, peer support, educational gifts, healthy food, and information about programs that are available to help families when the baby is born. Some attendees had never had a baby shower and were grateful for the experience. Allen County WIC is committed to helping children be the healthiest they can be.

Environmental Division:

After years of planning, revised Household Sewage Treatment System rules were adopted by the Ohio Department of Health on September 29, 2014 for statewide implementation beginning on January 1,2015. Implementation of these rules required staff training, information sharing with stakeholders and revisions to our regulation adopted by the Board of Health. Beginning in 2015, our department accepted responsibility from the Ohio EPA for the designing and permitting of small non-residential sewage systems which may serve small businesses. Our web page has been revised for the sewage program and now provides a wealth of information for system owners on how systems are designed and their operation and maintenance requirements. Empowering owners to know more about their sewage systems helps to preserve their investment and protect the environment from health hazards which can be created by malfunctioning sewage systems.

Vital Statistics:

The Vital Statistics office files records for births and deaths that occur in Lima, Delphos, and all of Allen County. Our files date back to December 1908, when the filing system for the state began. Ohio law only allows for the issuance of certified copies of birth and death records. Our office can now issue certified birth certificates for all births occurring in the State of Ohio. Any births outside of Ohio must be requested directly from that state. We do not accept personal checks, but require cash, money order, or cashier's check. We also offer the use of a debit/credit card machine with an additional usage fee applied to the cardholder. When possible, Vital Statistics staff issues copies while customers wait—approximately 10 minutes. On-line ordering is available via a link on our website: www.allencountypublichealth.org.

Health Education Division:

In 2014, the Health Education Division was active in many community initiatives that plan and address the health concerns of our community. In June, our Community Health Improvement Plan (CHIP) was adopted and unveiled to the community. ACPH is working with multiple community agencies to direct and complete the action steps that have been outlined in this plan. In addition, ACPH was a contributing member of our Community Health Assessment Planning Team. This group developed youth and adult survey tools that were administered this fall to gain information about the health status and the perceived needs of our residents. The results of this survey will be shared in April 2015. In addition to these projects, health education staff continue to be partners in community coalitions such as the Bike and Pedestrian Task Force, Safe Communities Coalition and the Northwest Ohio Rescue and Restore Coalition that focuses on Human Trafficking.

Public Health Preparedness/Emergency Response:

Several preparedness initiatives made big strides in 2014. Allen County Public Health took the lead for Ebola response planning in the county by meeting, planning and sharing information regularly with our community partners. Ready Allen County, the registry to quickly identify residents that need assistance responding to community emergency situations, now has 100 residents registered. Staff exercised our newly completed agency Mass Fatality Plan with participation from county and regional partners. Three new schools are participating in our SUDS program (Schools United in Disease Surveillance). Staff have also been working with schools on issues related to vaccine-preventable disease outbreaks.

^{*} Each year our budget is inflated by fees that we are required to collect and send to the state of Ohio. Most of these fees go to the Ohio Department of Health with a smaller share going to Ohio Children's Trust Fund, Ohio Family Crisis Centers, the Ohio Environmental Protection Agency, the Ohio Department of Agriculture, and the Ohio Department of Natural Resources. A total of \$236,510 was collected and sent on to Columbus in 2014.

ALLEN COUNTY BOARD OF HEALTH

As established in Ohio law, our seven member Board of Health is our policy-making body with authority to adopt regulations and establish programs to promote public health within the district. As of January 2015, Board members are Dr. Wilfred Ellis, MD, President; Eric Kerner, Vice President; Janis Carse; Marva Cowan; Scott Shutt and Kha Tran, MD. After 21 years of serving on the Board of Health, Don Schweingruber, has stepped down. He will be missed. The District Advisory Council will appoint his replacement to complete his term on the Board.

Six of the seven Board members are appointed by the mayors, township trustees, and county commissioners of Allen County. The District Licensing Council appoints the seventh member. The Board meets at 8:00 a.m. on the second Friday of each month, and meetings are open to the public.
