## **Vaccines Vital for a Healthy Community**

Vaccination is the process where individuals are intentionally exposed to an antigen (a substance which activates the body's defense system) in the hope of establishing protection from a given disease, or immunization, should the body encounter it again in the future. Vaccination is one of the greatest public health successes in our time. The use of vaccines has helped to greatly lower the number of vaccine-preventable diseases, such as measles, mumps and rubella. In 2016, ACPH gave 8,823 immunizations, 5,111 of which were to children without insurance participating in the Vaccines For Children Program.

Vaccines are good for both individuals and the public. Vaccines are monitored both before and after they are licensed to make sure that the individual benefits out-

weigh the risks. Adverse reactions to vaccines are rare, and usually include minor symptoms such as fever and soreness at the site of the shot. Following vaccination guidelines is important for individual health, but also impacts a community's health.



"Herd immunity" (or community immunity) occurs when the number of people immune to a communicable disease is high enough in a population that even those members who do not have immunity are protected by a firewall of immune individuals. Herd immunity is crucial for those members of a population that cannot safely get immunizations regularly or have not built up immunity; for example, the very young or those who are immunocompromised, such as cancer patients, transplant patients and persons with HIV. When vaccination rates in a community decline, this important benefit is lost, and communities are left susceptible to disease outbreaks.

In March of 2017, Allen County Public Health issued <u>"Vaccination Information, Facts & Resources"</u> to accompany ACPH's public statement on the importance of vaccines for public health. The full statement can be read on ACPH's website, <u>allencounty-publichealth.org</u>.
