## **PUBLIC HEALTH IN ACTION: COVID-19**

On December 31, 2019, news spread of dozens of cases of pneumonia and severe respiratory disease with an unknown cause being treated in China. A novel (new) coronavirus was soon identified. The general public did not take much notice of the news, but officials at the World Health Organization (WHO) were monitoring it closely - there have been other novel coronavirus outbreaks in the past 15 years that affected thousands across the globe.

Within 3 weeks, on January 20th, the first case of the disease caused by the virus was confirmed in the United States. The disease was named COVID-19 by the WHO on February 11th and was then identified in 23 countries. Italy was one of the hardest hit countries, with cases being identified as early as February 23rd.

By the end of February the United States began issuing travel restrictions to areas most affected by the virus. On March 10th, Ohio Department of Health Director Amy Acton, M.D. announced the first positive cases in Ohio. A national emergency was declared by President Donald Trump on March 13th. Throughout March, Governor DeWine and Dr. Acton implemented several orders for the residents of Ohio, which culminated in a STAY AT HOME order effective for the period of March 24-April 6, 2020. The need for further orders in Ohio will be assessed as the disease spreads throughout the state. The battle continues as this annual report is being produced.

Before the COVID-19 outbreak, Allen County Public Health had plans to celebrate and recognize the achievements in public health in Allen County and the State of Ohio over the past century. Such a celebration of public health is directly linked to another pandemic—The Influenza Pandemic of 1918. The reaction to that pandemic at the national, state and local level established the need for a public health system that would be prepared to act in the event of future health emergencies. In 1919, the Hughes Law prompted the formation of municipal and general health districts across Ohio, including the Allen County General Health District, serving the villages and townships in Allen County. This law created a uniform structure for each health district, including Boards of Health and the creation of the District Advisory Council, which appointed people to the Board. The Allen County General Health District Advisory Council met on October 15, 1919 and appointed the first Board of Health. The Griswold amendment, passed in late 1919 required a reorganization for the Board of Health and on January 8, 1920, the District Advisory Council met to fill vacancies on the Board and consider a new budget, therefore completing the establishment of the Allen County General Health District.

Allen County Public Health planned to celebrate the 100th Anniversary of Public Health in Ohio and Allen County throughout March of 2020, but realized in mid-February that plans would need to be postponed. ACPH staff have dedicated much of our public health resources to the COVID-19 response since March 16, 2020. A celebration of local public health will take place later in 2020.



### **ALLEN COUNTY BOARD OF HEALTH**

The health of Allen County residents depends upon the knowledge and vigilance of our public health workforce, which includes nurses, health educators, environmental health specialists, nutritionists, breastfeeding counselors, administrative and support personnel, a social worker and community health workers at Allen County Public Health. The activities of the public health work force are overseen by the Allen County Board of Health.

As established in Ohio law, the seven member Board of Health is our policy-making body with authority to adopt regulations and establish programs to promote public health within the district. Board members during 2019 included: Wilfred Ellis, MD, President, Eric Kerner, Vice President; Marva Cowan, Sherri Winegardner, Scott Shutt, Ross Kauffman and, Kevin Casey, DO.

Six of the Board members are appointed through the mayors, township trustees, and county commissioners of Allen County. The seventh member is a physician appointed by the other Board members. The Board meets at 8:00 a.m. on the second Friday of each month, and meetings are open to the public.


